

## **VENDOR APPLICATION AND RULES**

- 1. THE FESTIVAL RESERVES THE RIGHT TO LIMIT THE NUMBER OF VENDORS SELLING LIKE FOOD ITEMS.
- EACH FOOD VENDOR IS REQUIRED TO SUPPLY TWO HOSES FOR THEIR TENT: EACH HOSE MUST BE 50FT IN LENGTH: ONE FOR DRINKING WATER AND ONE FOR DRAIN LINE.
- 3. VENDOR MUST CALL THE HARRISON COUNTY HEALTH DEPARTMENT OR ACCESS THEIR WEBSITE IN ORDER TO OBTAIN A TEMPORARY FOOD SERVICE PERMIT. VENDOR MUST HAVE THIS IN ORDER TO HAVE A BOOTH AT THE FESTIVAL, REGARDLESS OF PRESENT FOOD PERMIT STATUS AT A DIFFERENT LOCATION. VENDOR MUST PROVIDE THIS CERTIFICATE PRIOR TO FESTIVAL. THE HARRISON COUNTY HEALTH DEPARTMENT CAN BE REACHED AT (304) 623-9308
- 4. VENDOR MUST PROVIDE PROOF OF LIABILITY INSURANCE COVERAGE FOR THE PERIOD OF TIME COVERING THE FESTIVAL.
- ALL VENDOR FEES MUST BE PAID IN FULL PRIOR TO SETTING UP ON THE STREET! CHECKS WILL NOT BE ACCEPTED AFTER JULY 31<sup>57</sup>!
- 6. Street locations will not be determined until all fees are paid!

"We are allowing FOOD VENDORS to sell water and soft drinks. All water and drinks MUST be purchased from WVIHF! All remaining drinks left over on Sunday will be your responsibility!
